Note 1: The aforementioned commodities shall be exempt from submitting license to customs. Supervision and administration of inspection and quarantine for them shall be performed in compliance with related national laws and regulations. Any directly purchased commodity shall be exempt from check of customs clearance sheet. Any bonded commodity purchased online shall be checked for customs clearance sheet upon the "Line 1" entry into the zone, but be exempt from the check of customs clearance sheet upon the "Line 2" exit out of the zone.

Note 2: For medical apparatus and instruments and special food (including health food, formula food for special medical use, etc.) that should be registered or filed for records in accordance with the law, relevant laws and regulations of China shall be abided by.

Note 3: Items with * attached are subject to the national tariff quota scheme, and are subject to amount limits. Adjustment will be made as appropriate according to the implementation situation.

Note 4: Commodity names listed above are the shortened form. Specific scopes are as provided by the tariff line.
